## **CONDITIONS OF ENTRY**

1. **Conditions of Sale** - All vehicles will be offered subject to Thimbleby & Shorland's usual Conditions of Sale, which will be printed in the catalogue and are available upon request
2. **Place of Sale** - Reading Auction Market, Great Knollys Street, Reading (off Caversham Road)
3. **Entries** - Entry forms should be in the auctioneers' hands as soon as possible and in any event not later than two weeks prior to auction for inclusion in the catalogue
4. **Delivery** - The Market will be open for receiving entries from **9.00 a.m. to 4.30 p.m.** on the day prior to each sale, or earlier by arrangement. **No vehicles will be accepted after 9.00 a.m. on sale day** (even though entered in advance). Late entry vehicles will be accepted between the same times.
5. **Reserve Prices** - All reserve prices should be clearly placed in the reserve box on the front of this form. Otherwise reserves must be made in writing by 5pm on the day prior to sale, otherwise no responsibility can be accepted by the Auctioneers for any errors.
6. **Liability** - The Auctioneers do not accept responsibility for any accident, loss or damage from any cause whatsoever which may occur on the auction premises. Unloading and loading facilities are available entirely at the risk of the vendor or purchaser, whichever the case may be. All lots are at the vendors' risk until sold and at the purchasers' risk thereafter.
7. **Clearance** - All lots become the responsibility of the purchaser at the fall of the hammer and any unsold lots remain the responsibility of the vendor. In any event all lots should be removed in their entirety from the market as soon as possible after the sale.
8. **Description** - All lots will be described to the best of the Auctioneers ability from information supplied by the vendors who alone shall be responsible for any error or mis-statement. The Auctioneers undertake no liability whatsoever in respect of faults, deficiencies & errors of description, oral or printed, nor do they accept responsibility for the authenticity, genuineness, condition, age, origin, mileage or quality of any lot and **no warranties** are given or implied except where identified by the vendor. The Auctioneers reserve the right to implement any checks & enquires they deem appropriate. Any false statements given by the vendor may constitute a criminal offence and/or breach of contract.
