3. **DELIVERY** - The Market will be open for receiving entries from 9.00am to 4.30pm on Tuesday or Wednesday prior to each sale, or earlier by arrangement. **NO DELIVERIES ACCEPTED ON THE DAY OF SALE.**
4. **RESERVE PRICES** - All reserve prices should be made in writing by **5.00pm** on the day prior to sale, otherwise no responsibility can be accepted for errors.
5. **LIABILITY** - The Auctioneers do not accept responsibility for any accident, loss or damage from any cause whatsoever which may occur on the auction premises. Unloading and unloading facilities are available entirely at the risk of the vendor or purchaser, whichever the case may be. All lots are at the vendors' risk until sold and at the purchasers' risk thereafter.
6. **CLEARANCE** - All lots become the responsibility of the purchaser at the fall of the hammer and any unsold lots remain the responsibility of the vendor. In any event all lots should be removed in their entirety from the market within 7 days of the sale.
